Her direct client service work primarily includes tax compliance, budgetary support, and general coaching and



consulting. Elaine educates the non-profit community through financial seminars and master classes. Hosts have included the Kennedy Center's DeVos Institute of Arts Management, the Foundation Center, the Arts & Business Council of New York, Americans for the Arts, the Ohio Art League, and the Juilliard School. Elaine also has contributed articles of interest to the non-profit sector to Guide Star, eHow Money, and Chron.com, and she plays a key role as an editor and accounting subject matter expert for Agate Publishing. She has developed business and entrepreneurial curriculum for institutions as varied as St. Lawrence University, the Miami Light Project, and the Playwrights of New York (PONY) fellowship program. She currently teaches finance as the Columbus College of Art and Design and in the Department of Art at the Ohio State University.
